Rating Action: Moody's upgrades one class of Spanish RMBS Notes issued by BBVA RMBS 10, FTA

Madrid, March 01, 2021 -- Moody's Investors Service ("Moody's") today upgraded the rating of Class B Notes of BBVA RMBS 10, FTA's and affirmed the rating of the Class A Notes.

The rating action reflects better than expected collateral performance and increased levels of credit enhancement for the affected Notes.

Moody's affirmed the rating of Class A that had sufficient credit enhancement to maintain the current rating on the affected Notes.

...EUR1376M Class A Notes, Affirmed Aa1 (sf); previously on Jun 29, 2018 Affirmed Aa1 (sf)

...EUR224M Class B Notes, Upgraded to Baa2 (sf); previously on Jun 29, 2018 Upgraded to Baa3 (sf)

BBVA RMBS 10, FTA is a securitisation of Spanish prime mortgage loans originated by Banco Bilbao Vizcaya Argentaria, S.A. (BBVA) (A2/P-1; A3(cr)/P-2(cr)) to obligors located in Spain. The portfolio consists of high Loan To Value ("HLTV") mortgage loans secured by residential properties.

The maximum achievable rating is Aa1 (sf) for structured finance transactions in Spain, driven by the corresponding local currency country ceiling of the country.

RATINGS RATIONALE

The rating action is prompted by an increase in credit enhancement for the affected tranches and decreased key collateral assumptions, namely the portfolio Expected Loss (EL) and MILAN CE assumptions due to better than expected collateral performance.

Increase in Available credit enhancement

Sequential amortization led to the increase in the credit enhancement available in this transaction. For instance, the credit enhancement for Class B affected by today's rating action increased to 8.1% from 6.7% since the last rating action.

Revision of Key Collateral Assumption

As part of the rating action, Moody's reassessed its lifetime loss expectation for the portfolio reflecting the collateral performance to date.

The performance of the transaction has continued to improve since last rating action. Total delinquencies have decreased in the past year, with 90 days plus arrears currently standing at 0.11% of current pool balance. Cumulative defaults currently stand at 0.59% of original pool balance up from 0.53% a year earlier.

Moody's decreased the expected loss assumption to 2.0% as a percentage of original pool balance from 2.5% due to the better than expected performance.

Moody's has also assessed loan-by-loan information as a part of its detailed transaction review to determine the credit support consistent with target rating levels and the volatility of future losses. As a result, Moody's has decreased the MILAN CE assumption to 11% from 14.6%.

Principal Methodology

The analysis undertaken by Moody's at the initial assignment of ratings for RMBS securities may focus on aspects that become less relevant or typically remain unchanged during the surveillance stage. The coronavirus outbreak, the government measures put in place to contain it, and the weak global economic outlook continue to disrupt economies and credit markets across sectors and regions. Our analysis has considered the effect on the performance of consumer assets from the current weak Spanish economic activity and a gradual recovery for the coming months. Although an economic recovery is underway, it is tenuous and its continuation will be closely tied to containment of the virus. As a result, the degree of uncertainty around our forecasts is unusually high.

We regard the coronavirus outbreak as a social risk under our ESG framework, given the substantial implications for public health and safety.

Factors that would lead to an upgrade or downgrade of the ratings:

Factors or circumstances that could lead to an upgrade of the ratings include: (1) performance of the underlying collateral that is better than Moody's expected; (2) an increase in available credit enhancement; (3) improvements in the credit quality of the transaction counterparties; and (4) a decrease in sovereign risk.

Factors or circumstances that could lead to a downgrade of the ratings include: (1) an increase in sovereign risk; (2) performance of the underlying collateral that is worse than Moody's expected; (3) deterioration in the Notes' available credit enhancement; and (4) deterioration in the credit quality of the transaction counterparties.

The analysis relies on an assessment of collateral characteristics to determine the collateral loss distribution, that is, the function that correlates to an assumption about the likelihood of occurrence to each level of possible losses in the collateral. As a second step, Moody's evaluates each possible collateral loss scenario using a model that replicates the relevant structural features to derive payments and therefore the ultimate potential losses for each rated instrument. The loss a rated instrument incurs in each collateral loss scenario, weighted by assumptions about the likelihood of events in that scenario occurring, results in the expected loss of the rated instrument.

Moody's quantitative analysis entails an evaluation of scenarios that stress factors contributing to sensitivity of ratings and take into account the likelihood of severe collateral losses or impaired cash flows. Moody's weights the impact on the rated instruments based on its assumptions of the likelihood of the events in such scenarios occurring.
