Rating Action: Moody's places on review for downgrade ratings of Notes in BANCAJA 13, FTA Spanish RMBS

Paris, March 14, 2021 -- Moody's Investors Service ("Moody's") has today placed on review for downgrade the ratings of Notes in BANCAJA 13, FTA. The rating actions follow Moody's review of the recent structural changes made to the transaction.

...EUR2583.7M Class A Notes, Aa1 (sf) Placed Under Review for Possible Downgrade; previously on June 29, 2018 Affirmed Aa1 (sf)

...EUR152M Class B Notes, Aa2 (sf) Placed Under Review for Possible Downgrade; previously on June 29, 2018 Upgraded to Aa2 (sf)

The maximum achievable rating is Aa1 (sf) for structured finance transactions in Spain, driven by the corresponding local currency country ceiling of the country.

RATINGS RATIONALE

Moody's analysed the impact of the appointment of Bankia, S.A.(Baa2/P-2; Baa1(cr)/P-2(cr))("Bankia") as the issuer account bank. According to our methodology, the ratings of classes A and B are constrained by the exposure to Bankia as account bank considering the current rating level of Bankia. However, the ratings of Bankia are on review for possible upgrade pending the merger with Caixabank, S.A.(A3/P-2; A3(cr)/P-2(cr)). As a consequence, Moody's has placed on review for downgrade the ratings of classes A and B to take into account the possibility that the merger is not completed as planned.

On 24 February 2021, the target amount of the reserve fund was reduced to EUR 143.3 million from EUR 173.5 million. It is now 4.95% of the initial amount of the Notes at closing. The current balance of the reserve fund is EUR 101.203 million. Moody's notes that the rated Notes have sufficient credit enhancements.

The coronavirus pandemic has had a significant impact on economic activity. Although global economies have shown a remarkable degree of resilience to date and are returning to growth, the uneven effects on individual businesses, sectors and regions will continue throughout 2021 and will endure as a challenge to the world's economies well beyond the end of the year. While persistent virus fears remain the main risk for a recovery in demand, the economy will recover faster if vaccines and further fiscal and monetary policy responses bring forward a normalization of activity. As a result, there is a heightened degree of uncertainty around our forecasts. Our analysis has considered the effect on the performance of consumer assets from a gradual and unbalanced recovery in the Spanish economic activity.

We regard the coronavirus outbreak as a social risk under our ESG framework, given the substantial implications for public health and safety.

PRINCIPAL METHODOLOGY

Factors that would lead to an upgrade or downgrade of the ratings:

Factors or circumstances that could lead to an upgrade of the ratings include: (i) performance of the underlying

collateral that is better than Moody's expected; (ii) an increase in the Notes' available credit enhancement; (iii) improvements in the credit quality of the transaction counterparties; and (iv) a decrease in sovereign risk.

Factors or circumstances that could lead to a downgrade of the ratings include: (i) an increase in sovereign risk; (ii) performance of the underlying collateral that is worse than Moody's expected; (iii) deterioration in the Notes' available credit enhancement; and (iv) deterioration in the credit quality of the transaction counterparties.

The analysis relies on an assessment of collateral characteristics to determine the collateral loss distribution, that is, the function that correlates to an assumption about the likelihood of occurrence to each level of possible losses in the collateral. As a second step, Moody's evaluates each possible collateral loss scenario using a model that replicates the relevant structural features to derive payments and therefore the ultimate potential losses for each rated instrument. The loss a rated instrument incurs in each collateral loss scenario, weighted by assumptions about the likelihood of events in that scenario occurring, results in the expected loss of the rated instrument.

Moody's quantitative analysis entails an evaluation of scenarios that stress factors contributing to sensitivity of ratings and take into account the likelihood of severe collateral losses or impaired cash flows. Moody's weights the impact on the rated instruments based on its assumptions of the likelihood of the events in such scenarios occurring.
