DBRS Confirms Ratings on Rural Hipotecario XV, Fondo de Titulización de Activos

DBRS Ratings Limited (DBRS) has reviewed Rural Hipotecario XV, Fondo de Titulización de Activos (the Issuer or RH XV) and has today confirmed the following ratings:

- Series A at A (sf)
- Series B at BB (sf)

The rating on the Series A notes addresses timely payment of interest and full payment of principal by the legal maturity date. The rating on the Series B notes addresses ultimate payment of interest and principal by the legal maturity date.

Confirmation of the ratings on the Series A and Series B notes (the Notes) is based on the following analytical considerations, as described more fully below:

- Portfolio performance, in terms of delinquencies and defaults, as of the May 2015 payment date.
- Updated portfolio default rate, loss given default and expected loss assumptions for the remaining collateral pool.
- Current available credit enhancement to the Notes to cover the Expected Losses at their respective rating levels.

The Notes are backed by a static portfolio of first-ranking mortgage loans secured by residential properties in Spain which were originated and continue to be serviced by three Rural Cooperative Banks: Globalcaja (Caja Rural de Albacete, Ciudad Real y Cuenca S.C.C.), representing 37.1% of the pool; Caja Rural de Asturias S.C.C. at 28.4% of the pool; and Caja Rural de Granada S.C.C. at 34.5% of the pool. The transaction closed in July 2013.

The current 90+ delinquency ratio, as a percentage of the performing balance of the portfolio, was 0.37% as of May 2015. Cumulative Defaults, defined as loans in arrears for more than 18 months, are currently at 0.05%.

The credit enhancement for the Series A notes (17.04%) consists of subordination of the Series B notes and a Reserve Fund initially funded via a subordinated loan. The credit enhancement of the Series B notes (5.68%) consists solely of a Reserve Fund. The Reserve Fund (EUR 26.45 million)

is fully funded and, given the current level of arrears and its non-amortising nature, is expected to continue providing support to the Notes.

The transaction also benefits from an amortising Second Reserve Fund (EUR 1.73 million) that provides additional liquidity to the transaction senior fees and Series A notes interest payments. This is currently funded at its target level (0.42% of the outstanding balance of the Series A notes).

This is a multi-originator transaction. The three Rural Cooperative Banks are the originators and servicers while Banco Cooperativo Español, S.A., whose Senior Long-Term Debt & Deposit rating is BBB (high) Under Review with Negative Implications by DBRS, was appointed as backup servicer of the transaction at closing.

Effective since 16 July 2015, Citibank International Limited (Citibank) has replaced Barclays Bank PLC as the Treasury Account Bank provider. Citibank is an eligible counterparty according to DBRS's Legal Criteria for European Structured Finance Transactions methodology.

The last rating action on this transaction took place on 23 July 2014, when the ratings on the Series A and Series B notes were confirmed.

To assess the impact of changing the transaction parameters on the rating, DBRS considered the following stress scenarios as compared with the parameters used to determine the rating (the base case):

- DBRS expected a lifetime base-case probability of default (PD) and loss given default (LGD) for the pool based on a review of the current assets. Adverse changes to asset performance may cause stresses to base-case assumptions and therefore have a negative effect on credit ratings.
- The base-case PD and LGD of the current pool of mortgages for the Issuer are 5.29% and 22.97%, respectively. At the A (sf) rating level, the corresponding PD is 17.80% and the LGD is 36.44% while at the BB (sf) rating level, the corresponding PD is 8.60% and the LGD is 26.33%.
- The Risk Sensitivity overview below illustrates the ratings expected if the PD and LGD increase by a certain percentage over the base-case assumption. For example, if the LGD increases by 50%, the rating of the Series A notes would be expected to remain at A (sf), assuming no change in the PD. If the PD increases by 50%, the rating for the Series A notes would be expected to remain at A (sf), assuming no change in the LGD. Furthermore, if both PD and LGD increase by 50%, the rating of the Series A notes would be expected to remain at A (sf).
